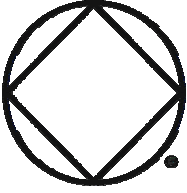

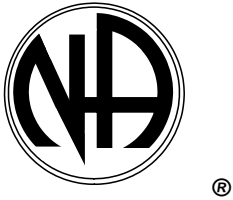
All committee have met their time lines. We have more than 100 pre registrations
