**12. Proposal #00214001P – Maker:** NA Way / **Supporter:** RAW in Carver Shores

To add the following to “I General Committee Guidelines”:

**Q.** Red Flags (or red cards)

1. Any member of the service body can raise a red flag, or a “red card”, during any part of the service committee meeting, to point out that our principals, traditions or concepts are not being followed.
2. The normal order of business will be postponed until the red flag (or red card) is decided upon by the GSRs
3. Only the GSRs can validate the red flag (or red card); by following the normal consensus business procedures for “Handling of a Block”.
4. In the event that this red flag (or red card) is validated by the GSR's, the activity or action taking place that is contrary to our principles, traditions or concepts will cease and desist.

**Purpose/ Intent:**

Our traditions protect us from the internal and external forces that could destroy us.

Ninth Concept: All elements of our service structure have the responsibility to carefully consider all viewpoints in their decision-making processes.

“... it is often the lone voice, offering new information or a unique perspective on things; that saves us from hasty or misinformed decisions. In Narcotics Anonymous, we are encouraged to respect that lone voice, to protect it, even to seek it out, for without it our service decisions would undoubtedly suffer.”

## 3/31/2016

In our current business procedures a red card can be used by the GSRs to point out that we are not following our principles, traditions or concepts during the call for consensus in new or old business. This is a highly valued and rarely used tool that allows our GSRs to be the lone voice mentioned above.

What the GOASCNA lacks in its business procedures is an avenue or opportunity for the other experienced members of its service body to exercise that red card (or be that lone voice). It also lacks an avenue or opportunity for any other service member to express that we are not following principles, traditions or concepts outside of new or old business (i.e. during Admin, Subcommittee, or Adhoc reports).

The proposal is intended to give any member of the service body any opportunity to raise the red flag, or a "red card", during any part of the service committee meeting, and point out that we are not following our principals, traditions or concepts. Further, to support our second concept "The final responsibility and authority for NA services rests with the NA groups", only the GSRs will validate the red flag (or red card) raised in this manner; by following the normal consensus business procedures for handling of a block.
