Phone-line Coordinator Report

- Phone-line Coordinator report - 124 total calls from 2/1-2/28; 11 Spanish speaking calls
- Coordinator II has been reaching out to all Phoneline volunteers - confirming all contact information - as well as asking whether things are operating smoothly and if they are receiving the updated information quickly
- A section will be added to the subcommittee meeting agenda for phoneline volunteers for questions, comments and concerns to be addressed
- All Phoneline volunteers have been added to the 12th Step Call Volunteer list - we are anticipating the need for addicts in recovery to be available to speak with addicts calling our phoneline to increase due to decrease of face to face meetings
- We reviewed the current meeting list so we would know which meetings were still available for face to face meetings, viewed our orlandona.org website together so everyone would know where to locate the virtual meetings and all other meeting information for our Phoneline volunteers to have when answering calls
- We also agreed as a committee that ONLY MEETINGS that are listed on our GOASCNA website will be given to callers and we would refer all callers to our website for information - We want to keep the information accurate and consistent for not only addicts seeking recovery but also any Professionals who are seeking information about NA - especially during this pandemic and to keep up with the ever changing information
- No New Orientations for Phone-line volunteers were given at this time

- Update and review of Community monthly meetings (Past Month)
- All Community meetings and events for the month have been cancelled, this includes
 - Seminole County Pre-Release Symposium
 - Orange County Coalition for Drug Free Community Treatment Provider meeting

 - These are available to people and facilities for the virtual meetings and other information
 - A committee member volunteered to check on the meetings in Osceola County and see if they can display the flyers at the meeting locations which are not meeting in person at this time
 - Flyers could go to the meeting locations where home groups meet to direct people to virtual meetings, Phoneline, NA Website
 - Ideal for two recovering addicts to go together
 - The committee agreed that members could put up the flyers at facilities
 - Anyone who goes to a facility/puts up flyers keep a running list and send that information to Liz B. and Mark B. so we can send a Thank you letter to those facilities who cooperated with us during this time
 - Stay Home orders are currently in Orange, Osceola and Seminole Counties - the committee members agreed that it would be in the best interest for Narcotics Anonymous as a Whole that our members and groups follow the order for the safety and in working in cooperation with our community and its leaders. We are well aware that we can not tell anyone what to do - we just want to give information and raise awareness about the seriousness of this COVID-19 pandemic
