

Change Parliamentarian 1 and 2 to Guide 1 and 2

**Change subcommittee Chairs and vice chairs to Leaders and Co leaders** 

Ad hoc committees should be called work groups

Elections—Elections should be held under Robert's Rules since there is either a yes or no vote

If a candidate is running unopposed they must receive 80% yes votes to be elected

In an election of 2 or more candidates they winning candidate must receive 1 vote more than 50%
