Greater Orlando Area Service Committee of Narcotics Anonymous RCM Report for April 9,2023

The next Regional weekend will be held May 19-21,2023 @Rosen Center Hotel @ 9840 International Drive, Orlando FL.

We'd like to start our report by thanking everyone that came out to support the GSR assembly weekend.

GSR Assembly 2023 was a great success, we had 195 people register for the GSR Assembly (3 more than last year), including 141 who pre-registered before arriving (17 more than last year). We actually had 162 people in attendance (7 more than last year), 157 in person and 5 online. 72 attendees identified as GSRs or Alternates.

For our regional conscience, we had 104 votes for the CAR and 28 votes for the Literature/IDT survey. We had 35 more CAR Votes than last year. 4 CAR Votes were by Online Meetings. **and Greater Orlando and Palm Coast had the most votes for an area with 11 each.** We generated a slidedeck for the Delegate Team's report with the results which shows how many groups from each area voted. On a quality note, we firmly believe electronic registration and voting ran pretty smoothly and we were able to assist anyone who had challenges.

- **Treasure Report**

- On January 1, 2023, the opening bank balance was \$49,855.43. After deposits of \$14,637.64 and expenses of \$8,151.67 on February 28, 2023, the ending book balance was \$56,341.40.
